

Privacy Policy

2. How We Use Your Data

We use your personal data for the following purposes:

- To process payments and manage billing.

- To respond to your inquiries and address customer service issues.

3. Legal Basis for Processing

We process your personal data based on the following legal grounds, as per the GDPR:

- **Consent:** When you provide explicit consent for us to collect and process your data (e.g., by signing a consent form or agreeing to receive marketing communications).
- **Contractual Necessity:** When processing your data is necessary for the performance of a contract with you (e.g., to provide treatments and services).
- **Legal Obligation:** To comply with legal and regulatory requirements (e.g., record-keeping for medical purposes).
- **Legitimate Interests:** For business purposes that do not override your rights and freedoms (e.g., improving our services or securing our systems).

4. Sharing Your Information

We may share your personal data in the following circumstances:

- With medical professionals and practitioners involved in your care and treatment.
- With third-party service providers who assist us with operations such as payment processing, marketing, and IT services. These providers are obligated to protect your personal data and use it only for the services we have contracted them to perform.

- In compliance with legal obligations, such as responding to court orders or regulatory requests.
- In the event of a business transfer, such as a merger, acquisition, or sale of assets, your data may be transferred as part of the transaction.

5. Data Retention

We will retain your personal data for as long as necessary to fulfil the purposes outlined in this Privacy Policy or for any other legitimate purpose, such as complying with legal, regulatory, or medical record-keeping requirements.

In general, we keep your personal data for:

- **Medical records:** As required by law (usually a minimum of 5 years after your last treatment).
- Marketing and communication data: For as long as you wish to receive such communications, or until you opt out.

6. Your Rights Under GDPR

Under the GDPR, you have the following rights regarding your personal data:

- **Right to Access:** You can request access to the personal data we hold about you.
- **Right to Rectification:** You can request correction of any inaccurate or incomplete data.
- **Right to Erasure (Right to be Forgotten):** You can request the deletion of your personal data, subject to certain exceptions.
- **Right to Restriction of Processing:** You can request that we limit the way we process your data under certain circumstances.
- **Right to Data Portability:** You can request a copy of your data in a structured, commonly used, and machine-readable format.
- **Right to Object:** You can object to the processing of your data, particularly in cases where we are relying on legitimate interests as our legal basis.
- **Right to Withdraw Consent:** If we are relying on consent to process your data, you may withdraw your consent at any time by contacting us.
